The subject solicitation is amended as follows:

1. The bid submission date is hereby changed from June 24, 2024 to Thursday, June 27, 2024 by 2:00pm EST.

Responses to written question(s) received from prospective bidder(s) are included below:

Question 1: Can you please remove section C.3.2 or provide more information. Would the recycling be in a roll-off or compactor.

<u>Response 1:</u> Section C.3.2 is revised to read "The Contractor shall provide these services throughout the full term of the contract. The Contractor shall consider such costs in the Contractor's bid price. Bidders shall be prepared and equipped to provide single stream collections for the District of Columbia Courts."

<u>Question 2:</u> Can you please remove section C.3.10.1 e) or remove utility carts, gaylords, pre-printed containers, and pallets.

Response 2: Section C.3.10.1 e) shall NOT be revised.

<u>Question 3:</u> Can you please remove the 8 cu yd container from Section C.3.10.3. 8 cu yd front end containers can not be transported by a roll-off truck.

<u>Response 3:</u> Section C.3.10.3 shall be revised to read the following: "Roll-Off Containers, Non-Compacting:

- a) The Contractor shall provide containers with the capacity of thirty (30) cubic yards capacities.
- b) The container shall be stationary and made of steel and shall be capable of being hauled by a standard tilt frame roll-off truck. Roll-off containers may be open top or may have some form of lid or covering. These containers will include some form of mechanical compactor, either attached as part of the container assembly, or as an independent unit that may be disconnected from the container for container transport.
- c) The containers shall be constructed from steel and shall be capable of holding a level full thirty (30 cubic yards of material without bulging, splitting of seams, damage to doors, or other damage of any kind."

Question 4: Can the monthly invoice be used as Monthly Report on Trash and Recyclables?

<u>Response 4:</u> No, the invoices do not provide the level of detail desired for trending and tracking purposes.

Question 5: Can you please extend the bid due date to 7/1/24.

Response 5: No, an extension will be granted until 6/27/24.

<u>Question 6:</u> Will you notify me if an amendment is issued or do I need to check the website on a regular basis.

Response 6: Yes, an amendment will be issued and distributed.
