ORDER GRANTING PLAINTIFF’S MOTION TO AUTHORIZE SERVICE BY POSTING AND TO EXTEND THE TIME TO FILE PROOF OF SERVICE

This matter is before the Court upon consideration of Plaintiff Veronica Elizabeth Lazo Molina’s (“Plaintiff”) Motion to Authorize Service by Posting and to Extend the Time to File Proof of Service on Defendant Luis Antonio Miranda (“Defendant”) filed on December 2, 2024. The instant case involves a Complaint for Custody for one Minor Child. Plaintiff has filed a motion providing the details of her diligent search for Defendant, whose exact whereabouts are unknown.

Plaintiff hired an attorney in El Salvador, Attorney Israel Ernesto Ramirez Villalobos to ascertain Defendant’s exact location to effectuate personal service on him. Attorney Ramirez Villalobos had reason to believe that Defendant was incarcerated in the Terrorism Confinement Center (“CECOT”) in El Salvador, however, Plaintiff has been unable to independently verify this and has not been able to find any official record of Defendant’s incarceration in CECOT or elsewhere. Attorney Ramirez Villalobos is unable to visit the prison to serve Defendant directly as CECOT is the most secure penitentiary in El Salvador, in which detainees have completely lost their civil rights. On September 4, 2024, Attorney Ramirez Villalobos submitted a petition to the General Directorate of Penitentiary Centers in El Salvador

requesting to send Plaintiff's pleadings to Defendant in CECOT, however, that request was not granted.

The Court is satisfied that Plaintiff has made a diligent investigation of Defendant's whereabouts for purposes of ordinary service of process. The search was not successful. Furthermore, Plaintiff has given an adequate explanation of why she should be allowed to serve Defendant through posting in the Clerk's office and on the Court's website at <https://dccourts.gov/services/serve-notice> rather than by publication in a newspaper. The reason is economic.

ORDERED that Plaintiff's Motion is hereby **GRANTED**; and it is

FURTHER ORDERED that Plaintiff may serve Defendant Luis Antonio Miranda, the father of the Minor Child, A.S.M.L. (DOB: 7/09/2015) by posting on the Superior Court for the District of Columbia's website for a period of twenty-one (21) calendar days and in the Domestic Relations Clerk's Office, starting with the date of this order; and it is

FURTHER ORDERED that if Defendant Luis Antonio Miranda does not file a responsive pleading within twenty-one (21) days after service pursuant to the Rules Governing Domestic Relations Proceedings, Rule 12(a), Plaintiff may file a motion for default and the Court may enter default by order and may convert the next hearing into a default/ex parte hearing to take testimony from Plaintiff and file a final judgment without Defendant Luis Antonio Miranda's participation, and it is

FURTHER ORDERED, that if Plaintiff is seeking a default judgment, prior to the next scheduling hearing, Plaintiff shall file an Affidavit in Compliance with the Servicemembers Civil Relief Act; and it is


FURTHER ORDERED that a hearing on Plaintiff's Complaint for Custody and Amended Motion to Make Factual Findings to Permit Minor's Application for Special Immigrant Juvenile Status is scheduled for **January 23, 2025, at 2:00 p.m.** before Magistrate Judge Julie R. Breslow remotely on WebEx 99. Instructions on how to appear remotely are attached to this order; and it is

FURTHER ORDERED that the Minor Child, A.S.M.L, born on July 9, 2015, is not required to participate in the hearing but may appear if Plaintiff wishes for the Court to note on record her presence; and it is

FURTHER ORDERED that proposed orders shall be provided to the Court's chambers (magistratejudgebreslowchambers@dcsc.gov) in word format by Monday, January 6, 2025.

IF YOU WANT TO CHALLENGE THIS COMPLAINT, you must file a written objection with the Court within twenty-one (21) days, and appear for the hearing scheduled for **January 23, 2025, at 2:00 p.m. on Webex 99 or in-person in Courtroom HR-99 of the Moultrie Courthouse, 500 Indiana Avenue, NW, Washington, D.C. 20001**, that will be held remotely due to the coronavirus pandemic. Instructions to appear remotely are stated below and can be obtained in writing by contacting the chambers of Judge Breslow at MagistrateJudgeBreslowChambers@dcsc.gov in advance of the hearing. If you do not file a written objection within twenty-one (21) days or appear at the hearing, default may be entered against you, the hearing may be converted to a default/ex parte proof hearing and judgment may be entered without further proceedings. Your objection should be emailed to FamilyCourtCIC@dcsc.gov, and directed to the Domestic Relations Branch Clerk, Family Court, Superior Court of the District of Columbia, 500 Indiana Avenue NW, Washington, D.C. 20001.

IF YOU DO NOT WANT TO CHALLENGE THIS COMPLAINT, you may consent to the relief sought prior to the hearing scheduled for **January 23, 2025, at 2:00 p.m. on Webex 99 or in-person in Courtroom HR-99 of the Moultrie Courthouse, 500 Indiana Avenue, NW, Washington, D.C. 20001**.
