# ORDER GRANTING PLAINTIFF'S MOTION FOR ALTERNATIVE SERVICE BY POSTING

This matter is before the Court upon consideration of Plaintiff Maria Elena Saravia Hernandez's ("Plaintiff") Motion for Alternative Service by Posting on Defendant Unknown Father ("Defendant") filed on November 26, 2024. The instant case involves a Complaint for Custody for one Minor Child. Plaintiff has filed a motion providing the details of her diligent search for Defendant, whose whereabouts are unknown. The Court will not repeat those details herein. The Court is satisfied that Plaintiff has made a diligent investigation of Defendant's whereabouts for purposes of ordinary service of process. The search was not successful. Furthermore, Plaintiff has given an adequate explanation of why she should be allowed to serve Defendant through posting in the Clerk's office and on the Court's website at <a href="https://decourts.gov/services/serve-notice">https://decourts.gov/services/serve-notice</a> rather than by publication in a newspaper. The reason is economic. Accordingly, it is hererby,

**ORDERED** that Plaintiff's Motion for Alterative Service by Posting is hereby **GRANTED**; and it is

**FURTHER ORDERED** that Plaintiff may serve Defendant Unknown Father, the biological father of the Minor Child, M.P.S.H. (DOB: 09/12/2008), by posting on the Superior

Court for the District of Columbia's website for a period of twenty-one (21) calendar days and in the Domestic Relations Clerk's Office, starting with the date of this order; and it is

**FURTHER ORDERED** that if Defendant does not file a responsive pleading within twenty-one (21) days after service pursuant to the Rules Governing Domestic Relations Proceedings, Rule 12(a), Plaintiff may file a motion for default and the Court may enter default by order and may convert the next hearing into a default/*ex parte* hearing to take testimony from Plaintiff and file a final judgment without Defendant's participation, and it is

**FURTHER ORDERED**, that if Plaintiff is seeking a default judgment, prior to the next scheduling hearing, Plaintiff shall file an Affidavit in Compliance with the Servicemembers Civil Relief Act.

**FURTHER ORDERED** that a hearing on Plaintiff's Complaint for Custody and Motion for Special Immigrant Juvenile Status is scheduled for **Friday, March 28, 2025 at 2:00 p.m.** before Magistrate Judge Melanie A. Acuña remotely on WebEx JM-16. Instructions on how to appear remotely are attached to this order; and it is

If you do not file a written objection within twenty-one (21) days or appear at the hearing, default may be entered against you, the hearing may be converted to a default/ex parte proof hearing and judgment may be entered without further proceedings.
