ORDER GRANTING PLAINTIFF’S MOTION TO SERVICE BY POSTING

This matter is before the Court upon consideration of Plaintiff Maria Antonia Sanchez Melendez’s (“Plaintiff”) Motion to Authorize Service by Posting on Defendant “Jairo Doe,” (“Defendant”) filed on November 26, 2024. The instant case involves a Complaint for Custody for one Minor Child. Plaintiff has filed a motion providing the details of her diligent search for Defendant Jairo Doe, who is the putative father of the minor child. Plaintiff believes that Defendant Jairo Doe passed away when the minor child was approximately 4 years old. However, Plaintiff does not know if there is a death certificate for Defendant Jairo Doe and does not have access to obtain it or any other evidence of his death as she is not related to him nor in contact with anyone in his family. The Court is satisfied that Plaintiff has made a diligent investigation of Defendant Jairo Doe’s whereabouts for purposes of ordinary service of process. The search was not successful. Furthermore, Plaintiff has given an adequate explanation of why she should be allowed to serve Defendant Jairo Doe through posting in the Clerk’s office and on the Court’s website at <https://dccourts.gov/services/serve-notice> rather than by publication in a newspaper. The reason is economic.

ORDERED that Plaintiffs Motion to Authorize Service by Posting is hereby
GRANTED; and it is

FURTHER ORDERED that Plaintiff may serve **Defendant Jairo Doe/the Unknown Father** of the Minor Child, A.G.S.R. (DOB: 1/29/2007) by posting on the Superior Court for the District of Columbia's website for a period of twenty-one (21) calendar days and in the Domestic Relations Clerk's Office, starting with the date of this order; and it is

FURTHER ORDERED that if Defendant Jairo Doe/Unknown Father does not file a responsive pleading within twenty-one (21) days after service pursuant to the Rules Governing Domestic Relations Proceedings, Rule 12(a), Plaintiff may file a motion for default and the Court may enter default by order and may convert the next hearing into a default/*ex parte* hearing to take testimony from Plaintiff and file a final judgment without Defendant Jairo Doe/Unknown Father's participation, and it is


FURTHER ORDERED, that if Plaintiff is seeking a default judgment, prior to the next scheduling hearing, Plaintiff shall file an Affidavit in Compliance with the Servicemembers Civil Relief Act; and it is

FURTHER ORDERED that a hearing on Plaintiff's Complaint for Custody and Motion for Special Immigrant Juvenile Status is scheduled for **Monday, December 23, 2024 at 3:00 p.m.** before Magistrate Judge Julie R. Breslow remotely on WebEx 99. Instructions on how to appear remotely are attached to this order; and it is

JAIRO DOE/UNKNOWN FATHER, YOU ARE HEREBY NOTIFIED THAT a complaint for custody has been filed in the above-captioned matter.

IF YOU WANT TO CHALLENGE THIS COMPLAINT, you must file a written objection with the Court within twenty-one (21) days, and appear for the hearing scheduled for **Monday, December 23, 2024, at 3:00 p.m. on Webex 99 or in-person in Courtroom HR-99 of the Moultrie Courthouse, 500 Indiana Avenue, NW, Washington, D.C. 20001**, that will be held remotely due to the coronavirus pandemic. Instructions to appear remotely are stated below and can be obtained in writing by contacting the chambers of Judge Breslow at MagistrateJudgeBreslowChambers@dcsc.gov in advance of the hearing. If you do not file a written objection within twenty-one (21) days or appear at the hearing, default may be entered against you, the hearing may be converted to a default/*ex parte* proof hearing and judgment may be entered without further proceedings. Your objection should be emailed to FamilyCourtCIC@dcsc.gov, and directed to the Domestic Relations Branch Clerk, Family Court, Superior Court of the District of Columbia, 500 Indiana Avenue NW, Washington, D.C. 20001.

IF YOU DO NOT WANT TO CHALLENGE THIS COMPLAINT, you may consent to the relief sought prior to the hearing scheduled for **Monday, December 23, 2024, at 3:00 p.m. on Webex 99 or in-person in Courtroom HR-99 of the Moultrie Courthouse, 500 Indiana Avenue, NW, Washington, D.C. 20001**. FAILURE TO RESPOND IN THIS MATTER MAY RESULT IN THE ENTRANCE OF A CUSTODY ORDER WITHOUT YOUR PARTICIPATION.
