AMENDED¹ ORDER GRANTING PLAINTIFF'S MOTION FOR ALTERNATIVE SERVICE BY POSTING

This matter is before the Court upon consideration of Plaintiff Gerson Giovanni Rosa Guillen (“Plaintiff”) Motion for Alternative Service by Posting on Defendant Nelson Martinez (“Defendant”) filed on December 23, 2024. The instant case involves a Complaint for Custody for one Minor Child. Plaintiff has filed a motion providing the details of their diligent search for Defendant, whose whereabouts are unknown. The Court will not repeat those details herein. The Court is satisfied that Plaintiff has made a diligent investigation of Defendant’s whereabouts for purposes of ordinary service of process. The search was not successful. Furthermore, Plaintiff has given an adequate explanation of why she should be allowed to serve Defendant through posting in the Clerk’s office or on the Court’s website at <https://dccourts.gov/services/serve-notice> rather than by publication in a newspaper. The reason is economic.

ORDERED that Plaintiffs Motion for Alterative Service by Posting is hereby **GRANTED**; and it is

FURTHER ORDERED that Plaintiff may serve Defendant Nelson Martinez, the father of the Minor Child, R.E.G.M. (DOB: 02/26/2008) by posting on the Superior Court for the District of Columbia's website for a period of twenty-one (21) calendar days and in the Domestic Relations Clerk's Office, starting with the date of this order; and it is

FURTHER ORDERED that if Defendant Nelson Martinez does not file a responsive pleading within twenty-one (21) days after service pursuant to the Rules Governing Domestic Relations Proceedings, Rule 12(a), Plaintiff may file a motion for default and the Court may enter default by order and may convert the next hearing into a default/ex parte hearing to take testimony from Plaintiff and file a final judgment without Defendant Nelson Martinez's participation, and it is


FURTHER ORDERED, that if Plaintiff is seeking a default judgment, prior to the next scheduling hearing, Plaintiff shall file an Affidavit in Compliance with the Servicemembers Civil Relief Act; and it is

FURTHER ORDERED, that the hearing scheduled for **April 2, 2025, at 3:00 p.m.** is **VACATED**; and it is

FURTHER ORDERED, that a hearing on Plaintiff's Complaint for Custody and Motion for Special Immigrant Juvenile Status is scheduled for **March 5, 2025, at 12:00 p.m.** before Magistrate Judge Melanie A. Acuña remotely on WebEx JM-16. Instructions on how to appear remotely are attached to this order; and it is

IF YOU WANT TO CHALLENGE THIS COMPLAINT, you must file a written objection with the Court within twenty-one (21) days, and appear for the hearing scheduled **March 5, 2025, at 12:00 p.m. on Webex JM-16 or in-person in Courtroom JM-16 of the Moultrie Courthouse, 500 Indiana Avenue, NW, Washington, D.C. 20001.** Instructions to appear remotely are stated below and can be obtained in writing by contacting the chambers of Judge Melanie A. Acuña at MagistrateJudgeAcunaChambers@dcsc.gov in advance of the hearing. If you do not file a written objection within twenty-one (21) days or appear at the hearing, default may be entered against you, the hearing may be converted to a default/ex parte proof hearing and judgment may be entered without further proceedings. Your objection should be emailed to FamilyCourtCIC@dcsc.gov, and directed to the Domestic Relations Branch Clerk, Family Court, Superior Court of the District of Columbia, 500 Indiana Avenue NW, Washington, D.C. 20001.

IF YOU DO NOT WANT TO CHALLENGE THIS COMPLAINT, you may consent to the relief sought prior to the hearing scheduled for **March 5, 2025, at 12:00 p.m. on Webex JM-16.** For more information on how to file a Consent Answer, please contact the Family Court Self-Help Center by telephone (202) 879-0096.

FAILURE TO RESPOND IN THIS MATTER MAY RESULT IN THE ENTRANCE OF A CUSTODY ORDER WITHOUT YOUR PARTICIPATION.
