# ORDER GRANTING THE PLAINTIFF'S MOTION FOR ALTERNATIVE SERVICE BY POSTING

This matter is before the Court upon consideration of Plaintiff Jennifer Sarai Zelaya Mayorga ("Plaintiff') Motion to Authorize Service by Posting on Defendant Ramiro Solorzano Urrutia ("Defendant") filed on October 24, 2024. The instant case involves a Complaint for Custody and a Motion for Special Immigrant Juvenile Status on behalf of a Minor Child. Plaintiff has filed a motion providing the details of her efforts to serve Defendant. The Court is satisfied that Plaintiff has made efforts to personally serve Defendant and those efforts have been unsuccessful. Furthermore, Plaintiff has given an adequate explanation of why she should be allowed to serve Defendant through posting in the Clerk's office and on the Court's website at <a href="https://decourts.gov/services/servenotice">https://decourts.gov/services/servenotice</a> rather than by publication in a newspaper. The reason is economic. Accordingly, it is hereby

**ORDERED** that the motion be **GRANTED** permitting the Plaintiff to serve the Defendant by posting, and it is further,

**FURTHER ORDERED**, that Plaintiff may serve Defendant Ramiro Solorzano Urrutia, the father of the Minor Child, S.J.Z M. (DOB: 01/10/2013), by posting on the Superior Court for

the District of Columbia's website for a period of twenty-one (21) calendar days and in the

Domestic Relations Clerk's Office, starting with the date of this order; and it is

FURTHER ORDERED that if Defendant does not file a responsive pleading within

twenty-one (21) days after service pursuant to the Rules Governing Domestic Relations

Proceedings, Rule 12(a), Plaintiff may file a motion for default and the Court may enter default

by order and may convert the next hearing into a default/ex parte hearing to take testimony from

Plaintiff and file a final judgment without Defendant's participation, and it is

FURTHER ORDERED, that if Plaintiff is seeking a default judgment, prior to the next

scheduling hearing, Plaintiff shall file an Affidavit in Compliance with the Servicemembers Civil

Relief Act; and it is

FURTHER ORDERED that a hearing on Plaintiff's Complaint for Custody and Motion

for Special Immigrant Juvenile Status is scheduled for Friday, April 4, 2025 at 2:00 p.m. before

Magistrate Judge Melanie A. Acuña remotely on WebEx JM-16. Instructions on how to appear
